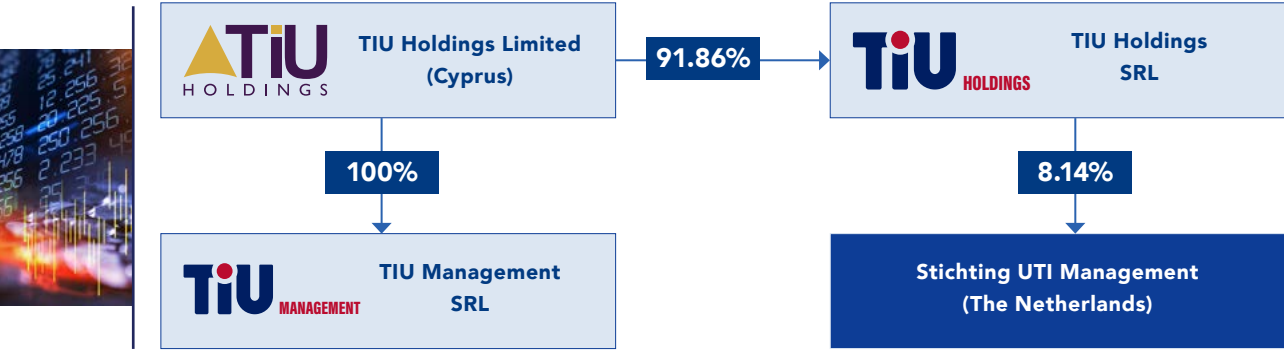

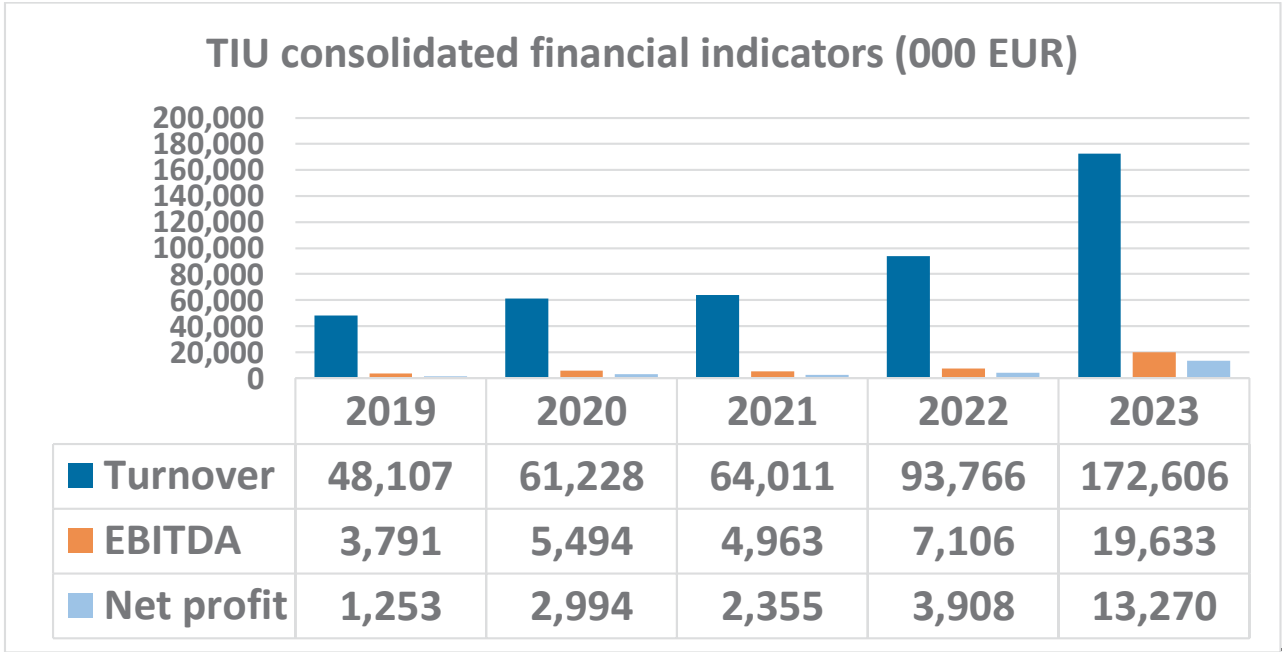

Trust services

The Trust Services line of business includes the activities for which certSIGN enjoys the highest recognition on the national market: qualified digital certificates for electronic signature, qualified timestamping services, qualified digital certificates for electronic seals, QWAC qualified digital certificates for website authentication, qualified digital certificates in accordance with the PSD2 directive (Banking Services Directive), standard digital certificate and for SSL server, timestamping services.

Digital identity

Trusted digital identity stands in the center of all digital transformation processes and certSIGN develops solutions that provides the security, protection, and efficient management of the digital identity, while guaranteeing that the digital identity belongs to the appropriate user. Card personalization, driving license issuance, production of cards for digital tachograph represent a part of our digital identity services, entailing smartcards personalization, certification services for smartcards and development and implementation of card issuance systems.



certME the first service in Romania to guarantee the identity in blockchain enables a single digital enrolment of a user, allowing several companies to share their digital enrollment processes.

Thus, companies can provide services to trusted digital identities (according to eIDAS Regulation) through exclusive online interaction with their customers.

In the context of the continuous digitalization of companies' activity, information cyber threats are increasing. certSIGN offers complete innovative solutions and services for companies that need protection of the information systems, covering both data security while data is in use, in transit or at rest and CSIRT services.

Data protection - relying mostly on certSIGN's proprietary products, the data protection services are oriented towards the implementation of technologies and the provision of services for data protection of an organization both at enterprise level (access, storage) and at endpoint level (desktop / laptop, mobile devices).

CSIRT services - oriented towards the implementation of technologies and the provision of cyber security services meant to monitor all IT infrastructures to prevent, respond and defend against cyberattacks. certSIGN has designed and operates its own SOC (Security Operation Center) that ensures the cyber protection of both certSIGN's infrastructure and of the clients' infrastructures.
